Why this document is relevant?

Jola's Voice and Data SIMs can be used across the globe to make calls, send messages and consume local network data.

When outside of the UK, depending on a) the country / region that the customer is in and b) the specific tariff that the customer is on, the SIM usage may:

- Be taken from the UK tariff allowances but incur an additional daily charge called 'Mobile Traveller' (*)
- Be taken from the SIM's UK data / calls / SMS tariff allowances at no additional cost.
- All be chargeable i.e. UK allowances are completely irrelevant. The specific charges will vary based on the country the phone is in.

* - There are three variants of 'Mobile Traveller', each represents a different daily charge. Which of the different Mobile Traveller charges applies depends on the tariff that the customer is on

- 'Mobile Traveller'
- 'Mobile Traveller - O2 Regular'
- 'Mobile Traveller - Globetrotter'
- 'Euro Mobile Traveller'

Fair Use Policy

Inclusive roaming services on Jola's mobile tariffs have been built for business users who travel periodically, and not those who roam across foreign networks on a semi-permanent or permanent basis.

If a customer uses their mobile in destinations outside the UK that qualify for inclusive access to standard bundles (this includes those countries that qualify for daily roaming services such as World Traveller and/or legislation such as Roam Like At Home), and they have spent more time abroad than at home with their roaming use exceeding their domestic use, we will consider them a permanent roamer and charges will apply in line with our standard roaming out of bundle costs. Roaming activity will be measured over a four month period.

Overview of all Voice & Data tariffs

NB – On the ‘unlimited data’ tariffs the maximum total amount of roaming data (EU plus any of the Rest of World zones) is 25 GB.

Any roaming data consumed above 25GB is chargeable.
